The Town of Tonopah Outstanding Citizen of the Year Award is given to honor an individual, couple or family whose impact through the years will be recognized and regarded with pride as a role model for the community. The outstanding citizen is chosen for their definable, exceptional deeds, with which he/she/they has made to our community.

Nominations for the Town of Tonopah Outstanding Citizen are accepted throughout the year and awarded to individuals meeting the selection criteria.

Nominations must be submitted via a written application form and **delivered to the Town Office at 140 South Main Street, Tonopah, Nevada or mailed USPS to Post Office Box 151, Tonopah, Nevada 89049**

Criteria for Nominations:

1. An Individual must be a full-time resident of Tonopah. Couples or Family nominations are accepted as well as individuals. An individual who meets the criteria but has passed away during the current calendar year may also be nominated.
2. Individual(s) has clearly enriched life within the Town of Tonopah.
3. Individual(s) has clearly shown a willingness to work with other Tonopah residents and has shown a wide-ranging support of Tonopah.
4. Individual(s) who has demonstrated exceptional commitment, service, creativity, cooperation or leadership.
5. The Nominee may **NOT** be a **Past Outstanding Citizen Award Recipient.**

To be considered, all nominations must include the following:

- Complete Nomination Packet. Incomplete nominations will not be considered.
- The individual(s) nominated must be a current resident of Tonopah,
- The individual submitting the nomination must clearly define why they feel the person being nominated is deserving of this award.
