BACKGROUND OF ACTION ITEM REQUESTED:

The current seasonal lights are decades old and need regular maintenance which is not cost-effective due to man-hours. Staff would like to purchase new lights in a star design that will compliment Tonopah's fame for stargazing. More traditional lights (wreath, candy cane, etc.) are available if the Board would prefer this option.



FISCAL IMPACT:

Twelve (12) star-lights, 4.5 x 7.5 feet, with LED's for a cost of \$6,052.34, including shipping, to be paid out of Town Maintenance Equipment Repair/Maintenance Fund.
